2. As all participants are below the age of 18, parental consent is mandatory;
3. Archery Association of Singapore (“AAS”) shall retain the right in its sole discretion to revise any of these terms and conditions, or at any time without prior notice and/or assuming any liability to any party;
4. Archer is not allowed to interfere with the running or organise of the competition. Doing so will result in barring of the club and the archer from participating in future competition;
5. The participant / parent / Guardian has agreed on the following Rules and Regulations. He / she will be indemnified, save and hold harmless Archery Association of Singapore, appointed officials, management and its officers, servants, employees, agents or volunteers against all losses, claims, suits, demands, actions, proceedings, damages, costs or expenses, including legal fees, whatsoever in respect of death, injury, disability or any other liability arising in any way from this competition; charges of any kind howsoever incurred by or on behalf of or made against the Archery Association of Singapore;

Archery Association of Singapore reserves the right in its sole discretion to refuse admittance to any archer / parent / Guardian or to require any archer / parent / Guardian to leave if in their opinion his or her behavior is in breach of these rules and regulations or of any rules and regulations of Archery Association of Singapore, or contravenes applicable laws and regulations generally applying. The opinion of Archery Association of Singapore is final in this regard;
